Why is it important for people to take part in our work?



People who have used social services and carers are very important.

They can help make services better.



We want to make sure that people who have used social services and carers can have a big say.

They should be able to:

- tell us, the government and other organisations what needs to change
- help make laws, plans and decisions about social services.



When people who have used social services and carers have a say it can help them and our work.

For example, it can help people to:

- learn new things
- meet new people.

And it can help us all plan together for the future.

How we will make sure that people can take part in our work



We might work with people on many different things, like:

- projects
- finding out what people think of our work and learning from their ideas



 information to help people who work for social services to learn new things and follow the law.



It is important for us to:

- work with people in a way that suits them
- listen to people and respect them



- make sure people have a real say
- make sure lots of different people and groups can have a say



 learn from what people tell us and change things if we need to.

The main things we will do in the next year



We will work with people who have used social services, carers, staff and other people to:

- do the things in this plan
- check how the plan is working and see what needs to change.



In the next year we will make sure we are ready for lots of people and staff to have a say in our work.



1. We will make sure that everyone who works for us knows why it is important for people to have a say in our work

We will make a document about making sure people can take part in our work and how we will work with them.



We will also:

 set up a way to keep information about who has a say in our work and the difference it makes



 look at anything that might be unfair for people when they take part in our work



 set up a group of staff who can help other people know why it is important for people who have used social services and carers to be part of our work



 make sure people who have used social services and carers can help us choose new staff and give staff training



 test how it is working for people to have a say in our work. We will test this with 2 projects we are doing



 make sure people who have used social services and carers help us make a big plan about our work from 2021 to 2024.



2. We will make sure that people know how they can take part in our work

We will:

 make a document about the people and groups we already work with



 put information on our website and make other information to tell people how they can take part in our work



 get in touch with other people and groups who have not had a say in our work yet



share information about this plan and how it is working.
